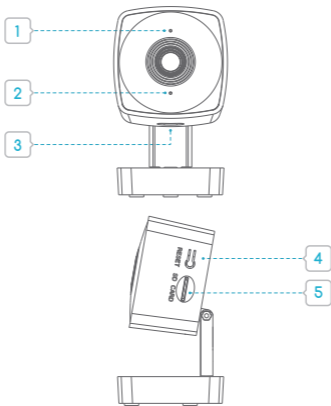
1 Indicator light

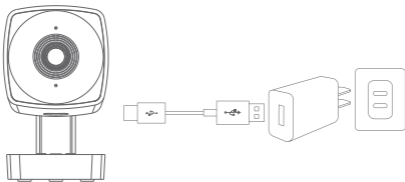

- ▶ Do not use the camera in the environment at too high or too low temperature, never expose the camera under strong sunshine or too wet environment. The suitable temperature for the product and accessories is -10°C - 50°C .
- ▶ The plug considered as disconnect device of adapter. If you use a third-party charger, the recommended output voltage/current of the adaptor is DC 5V/1A, and the adapter shall be CE approval type.
- ▶ RF exposure information: The Maximum Permissible Exposure (MPE) level has been calculated based on a distance of $d=20$ cm between the device and the human body. To maintain compliance with RF exposure requirement, use product that maintain a 20cm distance between the device and human body.
