## 1. Hubungkan kamera anda

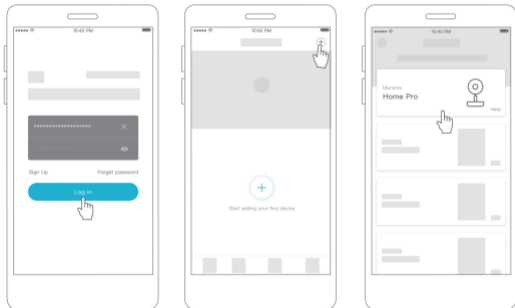
